
- 1) During the financial year 2022-23 there is no receipt and no expenses occurred by political party. So there is no Receipt and payment account for the F.Y 2022-23.

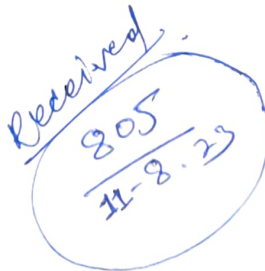
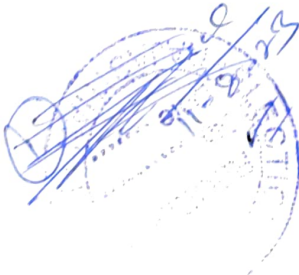
